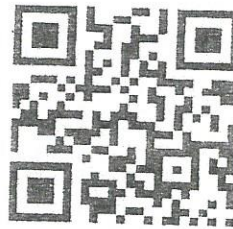

Incorporations.is attached hereto marked and exhibited as **GP-2**. A copy of the Certificate of Change of Name is attached hereto and marked **GP-3**.




A.D. 2013 and the Directors of the said Company never received any Notice to this affect.

5. I make this affidavit in Support of an Application that CSIAG be restored to Register of International Business Companies.

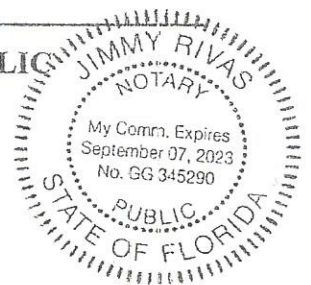
